Jesse: Typically council does not fund outside-Sixth organizations. This is a safeguard because once we start funding outside organizations, people start looking at council as piggy bank.

Winnie: We are explicitly not allowed to fund organizations not registered under Sixth college.
Jesse: The only exception is Muir musical -- there are a lot of Sixth college students involved in the Muir musical.
Myra: I was in Finance Committee - they are doing a lot of audits on organizations that violating funding guidelines. Not sure if MSA is one of the organizations being being audited.
Andy: Do you know roughly how many Sixth college students attend this event?
Winnie: Did not tell us.
Rachel: Is there any way for us know this information before we vote?
Andy: There are so many student cultural organizations. I think the conversation has to be why are we specifically funding this org over others?
Tommy: Has there been a case where we suspend bylaws to fund something else beisdes Muir Musical?
Jesse (Point of Clarification): I can't think of any other time during four years here of suspending bylaws.
Winnie: Only outside org we have funded is Muir Musical
Jamshed: Do they tell us how many Sixth students at Muir Musical? Is the information verified?
Andy: Yes - they have tallies. The information is trusted.
Sophia: What line item is funded if we do fund them?
Winnie: Unallocated
Jamshed: When is their event? Can we table discussion until next week?
Andy: It is February 11, so yes we can. It might be cutting it close for the organization, though. Ultimately, we should be thinking about how we can argue that this event is different than other events that we are funding this over everything else we have not funded in the past?
Myra: Make sure that we have items we check for to fund outside organizations. Let's keep consistency.

Daniel H.: I agree. If we want to shut down this budget for being an outside organization, then it's only fair to discuss why we are funding Muir Musical. If we're saying it's because they can provide us numbers of how many Sixth College students there are, then any organization in the future can easily do that as well.
